

3. I do not collect garbage for Cortes Island. I have never been involved with garbage collection on Cortes Island. In the two and half years I have lived on the island, I have worked as a self-employed artist and a seasonal employee at Hollyhock.
4. I donated \$20 to the "Bernie's Cabin Fire Rebuild" GoFundMe campaign to support Bernie Anderson when his cabin caught fire. This was done purely in the spirit of community support, to help out a neighbour in a time of need. To suggest that I donated such a small sum with the goal of some kind of compensation from Director Noba Anderson is ridiculous.
